
## Cardinal Newman PA Sponsored Read 2025

One of the schools big ambitions for the PA fundraising efforts this year is to install an OPAL play sandpit in the school field to enhance the children's outdoor learning opportunities, sensory spaces and environments to create, play and socialise. To help us deliver this goal and get kids excited in the run up to world book day we would love your support in running a sponsored read.

Tying it to our goal of a new sandpit for the school we have set the children a variety of challenges along this theme; Sand, Castles, Beach, Holidays, Building. We will encourage all participants to read books around these topics to raise funds through sponsorship (and to give them a challenge over half term). The Challenge will start on the 1st Feb and run up to the 7th March. There are 10 challenges with a few spot prizes indicated by a star.

Once the challenge is complete any sponsorship money raised can be sent in with their completed forms in their book bags. Or if a parent/carer wishes to transfer directly to the PA Account please ensure the donation is labelled as **Sponsored Read**, and that the child's sponsor form is sent in.
